#### 38 USC 320(b)(2) (2004)

- Support for the JEC "shall be provided at a level sufficient for the efficient operation of the Committee, including a subordinate Health Executive Committee, a subordinate Benefits Executive Committee, and such other committees or working groups as considered necessary by the Deputy Secretary and Under Secretary.
- The HEC is working to institutionalize VA and DoD sharing and collaboration efforts to ensure the effective and efficient use of health services and resources.

# VA-DoD Health Executive Committee (HEC)




- 1982 38 U.S.C. § 8111 codifies sharing of DoD and VA healthcare resources
- 1995 MOU allows VA authorized to treat CHAMPUS (TRICARE) beneficiaries
- 2003 NDAA authorizes DoD-VA Health Care Sharing Incentive Fund (Joint Incentive Fund) and codifies Joint Executive Committee
- 2008 DoD/VA Health Care Resource Sharing Guidelines MOU signed
- 2010 NDAA authorized 5 year Demonstration project for integrated federal facility (James A. Lovell Federal Health Care Center)
- 2016 Supplement to DoD/VA Health Care Resource Sharing Guidelines MOU signed
- 2018 VA signs contract to use same Electronic Health Record as DoD
