VA-DoD Joint Executive Committee (JEC)




- The JEC is a VA-DoD interagency committee established by 38 U.S.C. §
 320 in 2004. The JEC is co-chaired by the DepSecVA and the USD(P&R)
 to oversee health care coordination and sharing activities between both
 Departments.
- In 2012, the Senior Oversight Committee was consolidated into the JEC, and expanded oversight of wounded, ill and injured issues.
- The JEC meets quarterly or as needed, with host responsibilities alternating between both Departments. DoD will host the next JEC which is scheduled for September 21, 2018. DoD membership of the JEC is at the discretion of the USD(P&R). The primary committees that report to the JEC are chartered separately and include:
 - Health Executive Committee (HEC)
 - Benefits Executive Committee (BEC)
 - Interagency Program Office (IPO)
 - VA-DoD Suicide Strategic Decision Team (SDT)
- The JEC is required to submit an Annual Joint Report to Congress on its activities.
- The JEC publishes a triennial Joint Strategic Plan (JSP). The JSP for FY 2019-2021 is currently in development.


